

# KEY INVESTOR INFORMATION

This document provides you with key investor information about this fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this fund. You are advised to read it so you can make an informed decision about whether to invest.



## Tiber Diversified UCITS Fund a Sub-Fund of MontLake UCITS Platform ICAV, managed by MLC Management Limited GBP Institutional Class A Shares (IE00BFXG8F00)

### Objectives and Investment Policy

The Sub-Fund's objective is to increase the value of your shares over the medium to long term.

The Sub-Fund will seek to achieve its objective by taking exposure through exchange traded futures to a systematic program called the TIBER Diversified Program (the "**Strategy**"). The Strategy which is 100% systematic provides exposure to the major indices in world equity markets, bonds, currencies and commodities (the "**Sectors**"). The Strategy is applied over a wide range of time frames (i.e. intraday to intermediate term) and seeks to identify price trends in the Sectors.

The Sub-Fund may also invest in structured financial instruments which are deemed to be transferable securities. The structured financial instruments will replicate the commodity exposure of the Strategy and provide the Sub-Fund with exposure to metals, energy, agricultural and soft commodities, such as coffee, cocoa and sugar. The investment by the Sub-Fund in the structured financial instruments shall not exceed 20% of the Net Asset Value of the Sub-Fund.

The Sub-Fund can take long and short positions through the use of derivatives, which may result in the Sub-Fund being leveraged. Leverage magnifies the exposure of the Sub-Fund to the underlying investments. In such situations, Sub-Fund returns may rise or fall more than they would have done otherwise, reflecting

such additional exposure.

It is expected that by using derivatives, the Sub-Fund's long and short positions may each be up to 100% of the net asset value of the Sub-Fund and, when netted off against each other, the Sub-Fund may be between 100% long or short at any given time.

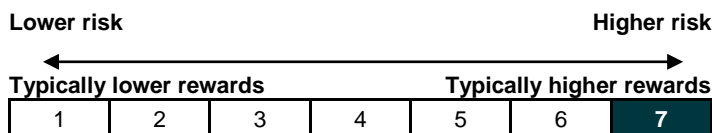
You can sell your shares on any day that banks are open in Ireland and the UK. You must submit your application to the Sub-Fund's Administrator no later than 1.00 p.m. one business day prior to the business day on which you want to sell.

Your shares do not pay you income, but instead the Sub-Fund reinvests such income to grow your capital.

As your shares are denominated in Sterling and the Sub-Fund is in Euro, forward contracts are used to attempt to eliminate the effects of changes in the currency exchange rates.

Recommendation: the Sub-Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

### Risk and Reward Profile



The risk category for this Sub-Fund is set at 7. It is calculated in line with EU regulations and is based on the risk limit for the Sub-Fund.

A **category 1** Sub-Fund is not a risk-free investment - the risk of losing your money is small, but the chance of making gains is also limited. With a **category 7** Sub-Fund, the risk of losing your money is high but there is also a chance of making higher gains. The seven-category scale is complex. For example, a category 2 Sub-Fund is not twice as risky as a category 1 Sub-Fund. The risk category shown is not guaranteed and may change over time.

When categorising the Sub-Fund it may happen that not all material risks were fully captured in the methodology. For a more detailed explanation of risks, please refer to the "Special Considerations and Risk Factors" section of the prospectus.

**Credit and Counterparty Risk:** The Sub-Fund deposits cash as margin for its derivatives positions with brokers and counterparties and may invest in debt securities or money market instruments. The Sub-Fund is therefore exposed to the risk that a counterparty or credit institution may become unable to meet its financial obligations or declare bankruptcy.

**Derivatives and Leverage Risk:** The Sub-Fund may use financial derivative instruments for taking short positions for investment hedging purposes. Whilst this is intended to help the Sub-Fund to manage risk or to take investment positions more efficiently or effectively than could be done

otherwise, leverage and shorting can involve the risk of higher volatility, especially if some of the expected offsetting positions between long and short investments do not work as expected, and the Sub-Fund may be exposed to additional risks and costs as a result.

**Investment Strategy Risk:** The Sub-Fund's success is dependent on the performance of the Strategy. The strategy is expected to have low to moderate volatility. The different markets traded or individual positions held by the Sub-Fund may be highly correlated to one another at times and may expose the Sub-Fund to significant losses. The Sub-Fund places significant reliance on its relationships with third parties and the loss of these services may adversely affect the Sub-Fund. Trading decisions are based on mathematical analysis of technical factors related to past performance and market activity such as price fluctuations or trading volume variations. The profitability of such a strategy depends on the occurrence in the future of relevant price moves and the ability of the strategy to continue to successfully identify the market trend which the Strategy uses to make profits.

**Short Selling Risk:** The Sub-Fund may create synthetic short positions through the use of derivatives. Short positions behave differently to long positions; for example, the Sub-Fund can come under pressure to close out short positions at short notice and before an offsetting long position can mature. This can create unexpected losses from positions that might otherwise have been seen as low risk or well hedged.

## Charges

The charges you pay are used to pay the costs of running the Sub-Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

This means that the holdings of the Sub-Fund are held separately under Irish law from the holdings of the other Sub-Fund of MontLake UCITS Platform ICAV.

You may switch your shares to the shares of another Sub-Fund of MontLake UCITS Platform ICAV free of charge.
